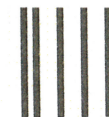

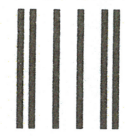

Return ballot **by mail**: **postmarked no later than Election Day** (to be counted, it must also be received by our county no later than 17 days after Election Day). **Warning:** Voting more than once in the same election is a crime.

I declare as follows:

1. I am a member of the active or reserve components of the United States Army, Navy, Air Force, Marine Corps, or Coast Guard; a Merchant Marine; a member of the United States Public Health Service Commissioned Corps; a member of the National Oceanic and Atmospheric Administration Commissioned Corps of the United States; or a member on activated status of the National Guard or state militia; or an eligible spouse or dependent of such person; or an eligible U.S. citizen living outside of the territorial limits of the U.S. or the District of Columbia; and 2. I am a U.S. citizen, at least 18 years of age or older on Election Day, and I am eligible to vote in the California jurisdiction in which I am voting with the enclosed/attached voted ballot; and 3. I am not currently imprisoned, or on parole for the conviction of a felony, and 4. I have not been found by a court to be mentally incompetent, or if so, my voting rights have been reinstated; and 5. I am not registering, requesting a ballot, or voting in any other jurisdiction in the U.S., except the California jurisdiction cited in this enclosed/attached ballot; and 6. I am the person whose name appears on this envelope.

I understand that a material misstatement of fact in completing the ballot may be grounds for a conviction of perjury under the laws of the State of California or the U.S.

I declare under penalty of perjury under the laws of the State of California or the U.S. that the foregoing is true and correct.
